Symptomatic testing: 10.81% Asymptomatic testing: 1.90%

Discharges: 3,400 total COVID-19 discharges to date, 10 in the last 24 hours. These numbers include patients discharged to skilled nursing facilities but exclude deaths and discharges to hospice.

Deaths and hospice: Since March 10, 2020 Michigan Medicine hospitals have had 307 total deaths or discharges to hospice, 1 in the last 24 hours.

EMPLOYEE VACCINATION STATUS

Michigan Medicine has mandated all employees to receive the COVID-19 vaccination unless it is not an option in the contracts of bargained-for employees. This could change soon because CMS announced this week that the government will soon issue an emergency regulation related to the vaccination requirement and urged healthcare workers employed by covered facilities who are not vaccinated to begin the process immediately. Michigan Medicine's legal counsel are analyzing the federal guidance to determine whether this announcement will change which employees are subject to the mandate.

As of Nov.5, 2021, below are Michigan Medicine's most accurate vaccine statistics for employees covered under the mandate (excludes bargained-for staff):

Michigan Medicine Employees minus Unions that aren't mandated by policy (n=25,202)

- Fully Vaccinated 91.3%
- Partial Vaccinated/On Track to be fully vaccinated 0.3%
- Approved Exemptions 4.1% or 1,033 employees
- Non-Compliant 4.0% or 1,008 employees were not compliant with the mandate. 25 employees have resigned; others are under disciplinary action; and some are new hires, on leave of absence or have their submissions under review.

Of our bargained for employees not covered by the mandate (n=7,914), they were asked to declare whether or not they are vaccinated; however, since declaration is not covered in the contract, it is optional to report status. At least at least 74% of bargained for employees not covered by the mandate are vaccinated, but we believe the actual number is much higher.

COVID-19 VACCINATIONS FOR CHILDREN AGES 5-11

U-M Health is offering vaccination to children ages 5-11 at COVID-19 vaccination clinics, including Brighton Health Center, Northville Health Center and North Campus Research Complex

(Building 200) in Ann Arbor. Appointments are required and the location of your appointment will be noted when schedule your appointment at the MyUofHHealth patient portal.

When will HR begin processing reclassifications and is anything being done for those whose promotions have been on hold since the beginning of the pandemic?

Reclassifications and promotion requests have been ongoing since October 1, 2021. HR is working with segment leadership to prioritize compensation needs of each area. Deferred promotions that are part of established career or clinical ladder programs will be part of an immediate corporate officer review to

fast track where necessary. Work with your department leadership and HR Business Partner to determine eligibility.

Do you know when the review board will be processing Flu Exemptions? I submitted mine on September 3rd and have not heard back.

Flu shot exemption forms submitted by the November 1, 2021 deadline are being reviewed by their respective committees. All employees will receive an email regarding their exemption outcome within the next few weeks.

Is there a mechanism in place to allow us to upload documentation of our COVID-19 booster vaccines? If an employee receives their third and/or booster shot at any location outside of the OHS vaccine clinics, documentation should be provided to OHS, with the your name and UMID number on it, and sent directly to OHS via email to OHS-covideaccine@med.umich.edu.

FLU SHOT REMINDER - DEC. 1 DEADLINE

As of Monday, Nov. 8, Michigan Medicine is at **58.72%** compliance with the annual mandatory influenza vaccine policy. With three weeks left before the December 1 deadline, all employees are encouraged to get their flu shot now and not wait until the last day.

OHS will host onsite clinics across the medical campus throughout the next month, and we strongly encourage clinical units to utilize their flu liaisons to administer the vaccine. Employees may also utilize your doctor's office, pharmacy or community flu shot resources. If you receive your flu shot at any location outside of the OHS flu clinics, documentation must be provided, with the your name and UMID number on it, and sent directly to OHS via email to Flu-Occ-Health@med.umich.edu. OHS is experiencing a high volume of flu documentation and is processing this information as quickly as possible. If you submitted documentation to this email account you can be assured it will be entered as quickly as possible. Please allow 7-10 days for these to be entered into this system before contacting OHS.

Exemptions submitted by the November 1 deadline are being reviewed by their respective reviewing committees and notification of approval/denial will be sent prior to December 1.

As a reminder, this year there are no flu stickers required to place on your employee badge. Supervisors and Managers should utilize Health Rx to confirm their direct report employees flu compliance.
