COVID-19 BOOSTER SHOT REQUIREMENT AND REPORTING

To protect our workforce, patients and community, all Michigan Medicine faculty, non-bargained for staff and learners are required to receive the COVID-19 booster shot by Friday, Feb. 4, 2022, or as soon as you are <u>eligible</u>. Bargained for staff should refer to their respective collective bargaining agreements and corresponding MOU's for information on their requirements.

If an employee is not <u>eligible</u> to receive their booster by the Feb. 4 deadline, they must get it when they become eligible, which is six (6) months post a two dose vaccine series or two (2) months post a one dose series.

As of Jan. 5, employees will need to self-report their COVID-19 booster vaccine documentation into Wolverine Access via the <u>"Report COVID-19 Booster Information form"</u>. If an employee submitted their booster vaccine information to OHS or received their booster shot at an OHS clinic prior to Jan. 5, they do not need to re-submit documentation in Wolverine Access.

Medical and religious exemption requests are available for employees who received their primary COVID-19 vaccine series (two doses or a single dose of approved COVID-19 vaccine) and are requesting exemption from the booster vaccine. Requests must be submitted by Friday, Jan. 21, in order to receive a decision by the February deadline.

Those who already received an approved exemption for the primary vaccine series do not have to re-submit a request as their exemption will include the booster shot.

CONTINUE SAFETY PRACTICES AGAINST OMICRON AT U-M HEALTH

Please maintain these safety practices to protect yourself and others against the Omicron variant.

- Local transmission rates of COVID-19 are extremely high, with numerous exposures among health care personnel (HCP). Please remember to continue to mask at all times.
 - Masks should only be removed in a private office or when eating in a designated area while appropriately distanced from others. Click here for more on the face covering policy.
 - o Medical masks are required in clinical buildings for patient facing activities.
 - N-95 masks should be worn when caring for patients with symptoms or a positive COVID-19 test and during aerosol generating procedures (AGPs) regardless of COVID-19 status of patients. HCPs may choose to wear a fit tested N-95 respirator for other patient care activities.
 - Workforce members working in non-clinical buildings should consider wearing a medical mask. If a medical mask is unavailable wear a well-fitted, multi-layer cloth mask.

- Get boosted. You can schedule your booster appointment through OHS here.
- Stay home if you're sick, and contact OHS to get tested. If you have upcoming clinical duties in the next 48 hours, call OHS. Otherwise, report symptoms to OHS here.
- If exposed and you have not received your primary COVID-19 vaccine series, you should remain off work for 10 days from the date of your exposure and get tested at day 7 using a <u>community testing resource</u>. Exposures do not need to be reported to OHS.

Contact tracing

Workforce members who are identified to have had unmasked contact with someone with COVID-19 will be contacted with instructions for follow up. There is a high level of COVID-19 currently, and removing your mask around anyone without appropriate distancing is likely to lead to an exposure.

THERAPEUTIC OPTIONS FOR MILD-TO-MODERATE COVID-19

Since the beginning of the pandemic, there has been an ever-changing landscape regarding therapeutic options for the treatment of COVID-19.

Recently, the FDA provided emergency use authorization for two oral antivirals, Ritonavir-boosted Nirmatrelvir (Paxlovid) and Molnupiravir for the treatment of mild-to-moderate COVID-19 in

patients at high risk of progressing to severe disease. In addition to Sotrovimab, the only COVID-19 monoclonal antibody treatment active against the Omicron variant, these are promising options becoming available to manage COVID-19 patients.

These agents are provided by MDHHS in limited supply and are heavily restricted at this time. As supply changes, so will the restrictions.

Given the rapidly-changing landscape, please refer to the <u>Antimicrobial Stewardship webpage</u> and the <u>COVID-19 Outpatient Treatment Guidelines</u> for up-to-date information on available medications, current criteria and current processes to help manage these patients.

REMINDER: RESPONSIBLUE APP

To help keep Michigan Medicine as safe as possible, please note that employees and visitors who show a Red X in the ResonsiBLUE app will not be allowed to enter any facility. This policy has been in place since November and is designed to protect faculty, staff, learners, patients and visitors.
